WHEREAS, the COVID-19 injections were experimental, and thus, they could be deemed a violation of the Nuremberg Code, because test subjects, when threatened with the loss of their liberty, their license, or their career, were unable to “exercise free power of choice, without the intervention of any element of force, fraud, deceit, overreaching, or other form of constraint or coercion”; and

WHEREAS many of those recipients may have lacked “sufficient knowledge and comprehension of the subject matter involved [. . .] to make an understanding and enlightened decision”; and

WHEREAS, in a rush to formulate a response, HIPAA was shelved, patient rights were trampled, and some family members were kept from the bedsides of their loved ones regardless of their wishes or their medical POA; and

WHEREAS a radical series of protocols were instituted denying the benefits of natural earned immunity, reducing or eliminating vaccination safeguards for children and pregnant mothers, and severely curtailing a patient’s access to physicians for wellness checks and non-COVID related issues; and

WHEREAS any consideration of alternative treatments (Ivermectin or Hydroxychloroquine) were largely dismissed, and any consideration of the negative side-effects of state-sanctioned protocols (COVID-19 injections or ventilators or Remdesivir) were often downplayed; and

WHEREAS healthy individuals were forced to utilize medical devices—masks—in order to perform both necessary and daily activities and that these devices, which were never meant to be worn for extended periods and which often contained unhealthy particulate, subsequently caused a host of inadvertent health issues including oxygen deprivation, infection, and severe depression; and

WHEREAS many business owners found their freedoms either enhanced or eliminated, purportedly, for the sake of public health: some were granted protections from liability against vaccine-related injuries, some were declared “necessary,” while others were deemed “unnecessary” and were forced to shut down; and

WHEREAS unscrupulous individuals exploited this “health crisis” to justify new, and highly suspect, election practices; and

WHEREAS many of the Constitution’s protections were bartered away for safety’s sake, and as Ben Franklin warned, “Those who would give up essential Liberty to purchase a little temporary Safety, deserve neither Liberty nor Safety”;

AND WHEREAS these experts, these centers, organizations, and administrations have signaled a full-expectation, as well as a willingness, to return to masks and mandates and far more;

THEREFORE, BE IT RESOLVED that we, as the Republicans of Williamson County, as Americans, as God-fearing Conservatives, will refuse to blindly submit, and we thank our State Legislators for the protections they have already enacted, and beg them to do far more to protect our Medical Freedom and to prevent such a horrific overreach from ever happening again; and we ask for Governor Lee to task our state’s Attorney General to investigate violations of the Tennessee Constitution and other Covid-19 crimes.
